- Ensure appropriate project records are maintained.

 Committee
- Keep abreast of the market intelligence framework for better understanding of the ERP market landscape.

- Work with CLP Commercial and Procurement to oversee tender management function ensuring integration with overall commercial strategy of ERP Transformation.
