Our business includes power generation, transmission and distribution, and electricity and gas retail activities. Our goal is to meet Asia-Pacific's energy challenge in a sustainable manner from one generation to the next.

The Contracts & Procurement (C&P) function under CLP Power Hong Kong Limited oversees the operating company's circa HKD 20 billion annual expenditure with 1,200 suppliers across 50 categories of spend. C&P's vision is "to be an agile and responsible business partner, delivering customer value through supply chain expertise, collaboration, innovation and excellence".

The C&P organisation is structured by Category Groups (CG), which are combinations of categories and sub-categories of spend in key supply markets. Key teams include: Assets & Equipment (Generation and Transmission & Distribution), Fuels, IT & Telecom, Customer & Corporate Services, and Performance & Excellence (COE).

Assets & Equipment (A&E) - Generation covers a range of critical categories in power generation equipment and related services, including: turbines, generators, boilers, balance of plant equipment, controls and instrumentation, operations systems, plant and electrical/mechanical works, and maintenance / repair / overhaul services.

We are looking for a high caliber and experienced procurement professional to join the A&E-Generation category group and lead assigned category/sub-category teams.

## **Key Responsibilities:**

Reporting to the Senior Manager, A&E - Generation, the position will be responsible for:

- Procurement Transformation. Support C&P's transformation effort to transition to a new "Business Partnering" operating model, initiate and drive the adoption of new ways of working, actively develop and mentor team members through change management journey.
- Procurement Leadership. Plan, design and implement procurement engagements with internal Business stakeholders and external suppliers across each stage of the end-to-end procurement lifecycle (Source-to-Contract and Procure-to-Pay).
- Demand Management. Lead the C&P team's upstream engagement with relevant Business stakeholders to identify, evaluate and manage procurement demand pipeline.

- Category Management. Provide in-depth category and practice expertise in assigned OEM equipment and services categories; develop and implement long-term Category Business Plans and strategies to maximize long-term value and benefits delivered to the business.
- **Sourcing & Contracting**. Lead planning, development and implementation of market engagement strategies, including bid management, supplier proposal evaluations, commercial & contract negotiations, and post-award commercial & contract management.
- **Supplier Management**. Lead and coordinate Supplier Relationship Management (SRM) engagement with key strategic partners efforts to drive supplier delivery performance, strategic alignment and business development.
- **Risk Management**. Develop and implement effective supply chain strategies to manage CLPP's business and operations risk exposure with key suppliers (including supply availability, reliability, cost and sustainability).
- **Partnerships & Innovation**. Develop strategic relationships and innovation opportunities with key supply chain partners to realize improvements in safety, quality, delivery and cost management.
- **Governance**. Ensure compliance with procurement policies, processes and procedures whilst driving commercial effectiveness and strong business ethics.

## **Requirements:**

- University degree in Business, Procurement and Supply Chain, or other relevant discipline with Post-Graduate degree preferred.
- Membership and/or qualification from a procurement professional body (e.g. CIPS, ISM, etc.) preferred.
- Minimum 8 years' experience in relevant procurement roles with relevant category expertise and increasing level of team management responsibility.
- Demonstrated knowledge of procurement leading practices applied across diverse categories and organisations.
- Strong interpersonal, communication and stakeholder management skills.
- Dynamic, innovative and creative-thinking change advocate.
- Fluency in English required, fluency in Cantonese a distinct advantage.
