The appointees will be responsible for the Power Plant operation including BPPS/PBPS Generation Units, Auxiliary Systems and Gas Receiving Facilities, and to ensure that the electricity generation processes are operated and maintained in a safe, reliable, and efficient manner. Major duties include: -

- Execute shut-down and start-up of gas and plant facilities including switching, isolation and purging;
- Perform front-line gas processing plant operation as well as power plant equipment operation and maintenance in a safe and efficient manner;
- Provide technical and engineering support to the shift operation teams;
- Supervise, direct, and co-ordinate multi-disciplinary work teams and contractors' workforce to carry out overhaul jobs and other maintenance activities to ensure consistent work quality and job safety are maintained at all times;
- Act as an Authorized Person or a Senior Authorized Person to carry out gas purging, electrical and mechanical isolation and issuance of safety documents;
- Take lead in innovation initiatives and continuous improvement projects assigned by supervisor.

Requirements:

- A recognized university degree or equivalent in an engineering discipline plus at least 3 years relevant working experience;
- General knowledge of power plant engineering;

- Solid experience in engineering, operations, maintenance, or installation of heavy electrical/mechanical/control & instrumentation equipment;
- Previous exposures to power plant environment and related contracts development/management will be an advantage;
- A good team player with strong analytical skill and self-initiative;
- Proficient in both written and spoken English and Chinese (both Cantonese and Mandarin);
- Good knowledge of CLP Power operations safety policies & procedures, SHE policies, standards and requirements.
