- Analyze and diagnose equipment fault and defects. Troubleshoot complex problems and provide technical expertise.
- Prepare, review and update documentation and reports.
- Recommend changes to maintenance practices to improve work efficiency, safety standards and cost effectiveness.
- Prepare budgets, procure essential spares, monitor capital, operating and manpower expenses to meet performance targets of those assets under his / her responsibility.
- Supervise subordinates and contractors' workers and be accountable for the safe and quality execution of works at sites.
- Support station operation through participation in Maintenance-Operator. Carry out operational activities under supervision.

Requirements:

- Higher Diploma/ Certificate in Mechanical / Electrical / Electronic Engineering plus 5 years' relevant experience; or Ordinary Certificate in Mechanical / Electrical / Electronic Engineering plus 8 years' relevant experience. Candidates possess lesser academic qualification but with extensive relevant working experience will also be considered.
