- Organize and promote safety and health programs, workplace safety hazards and advise/implement control measures on incident prevention.
- Conduct safety audit and support external safety accreditation audit; formulate corrective and preventive actions as appropriate.
- Advise on strategic development plan for continual improvement of staff competencies in safety.
- Provide expert advice to management on various operations or activities in the Department.
