Reporting to senior staff in the New Build & Technology team, the appointee will provide technical direction and guidance for development and execution of new build and acquisition projects across the CLP Group.

The Position Profile:

- Conduct due diligence studies on potential projects for acquisition and provide review and input to investment cases for proposed projects.
- Participate in the development and execution of project contracting strategy, tendering, contractor selection, negotiation and award process in conjunction with the other work teams including Procurement and Supply Chain, Fleet Management, HSSE, Renewable Energy and Project Teams.
- Provide engineering support on project scope definition, option analysis and acceptance criteria evaluation; identify key project risks and government approvals required for project development.
- Review project designs and provide recommendations to Project Teams based on design codes and standards as well as industry best practices.
- Review construction schedules and contractor's conformity with contract terms and specification requirements. Provide advice to Project Teams for changes to work under construction due to unforeseen conditions.
- Provide project management support including review of execution of site construction projects, evaluation of alternative construction methodologies, formulation of site execution plans, and advice on QA/QC activities. Conduct checks to ensure projects are ready for start of construction by auditing project plan, contractor readiness, method statements, etc. Monitor and provide governance to ensure projects are executed as planned with regards to HSSE, scope, cost, schedule and quality.
- Assist Project Teams in preparation of lessons learned and Post Implementation Project Review. Identify and capture lessons learned and opportunities for improvement in future projects. Share experience and lessons learnt with relevant stakeholders and across the CLP Group.

- Assist in the development and implementation of the Project Management Governance System initiatives in line with the CLP Group's corporate requirements.

- A recognized university engineering degree in civil/structural or electrical disciplines.
- At least 5 years' relevant experience in engineering, construction, or project management.
- Knowledge of CLP Group's HSSE standards and corporate requirements.
- Ability to perform in a dynamic, multi-cultural, matrix organization and influence outcomes.
- Commercial mindedness, results oriented and strong initiative to adapt to a changing business environment.
