- Conduct and monitor HSEQ audit, and inspection with references to statutory requirements as well as pre-determined policies and programmes
- Formulate annual HSEQ Plan, targets, and objectives
- Lead cross-functional workgroups to assess potential HSEQ hazards, administrative irregularity and monitor the implementation of corrective actions
- Facilitate the compilation of the Department's business plan on HSEQ to tie in with BG strategies, targets, and policies
- Provide HSEQ information with both quantitative and qualitative assessments for Management's decision support
- Identify and recommend changes to HSEQ procedures and systems
- Liaise with relevant parties on all HSEQ matters and provide professional advice to Branch Managers
- Formulate and monitor training needs on HSEQ aspects of all staff and contractors
