We are looking for a high calibre technical professional to join the Telecommunications Branch of Technical Services Department. Reporting to an Engineer, the appointee will be responsible for the following duties:

- Perform network operation and maintenance works to achieve the KPI target of Smart Metering Platform
- Support team leader for end to end testing and measurement for Smart Metering Platform and related telecommunication networks
- Deploy and restore telecommunications services upon user requests, equipment fault and system upgrade and migration
- Plan and schedule routine maintenance of aforementioned telecommunications systems and the auxiliary systems and facilities
- Perform project works, system fault diagnosis, and investigation at the field, power substations and hilltop stations and in some cases with the support from contractors
- Provide training, supervise site work, and conduct audit check to ensure work done by team members and contractors comply with approved working procedures, safety requirements, related specifications, proper risk mitigation measures, appropriate quality and housekeeping standards and legal requirements
- Liaise and coordinate with internal and external stakeholders (e.g., customers) to ensure site activities (including planned outages) meet performance targets
- Conduct timely inputting of data in Company IT systems such as EWMS, EFMS, EPSS, IDMS, PSARS and other Document Workflow Control System (DWCS) as and when required
- · Perform emergency call-out work and work under adverse weather condition as and when required.

- Higher Certificate / Higher Diploma in Electronic, Electrical, Computer Engineering or Professional Diploma in Power Engineering or equivalent plus 2 years' relevant experience; OR

- Authorized Person Restricted Duties and Safety Supervisor qualification or equivalent would be preferable
