Applications are invited for the post of Technical Officer II in the Systems Engineering Branch of Technical Services Department. Reporting to Engineer I, the appointee will be responsible for providing technical support, fault investigation as well as project and site testing and installation activities in the areas of power quality (PQ) issues for the electrical power systems.

The appointee will be responsible for the following duties:

- Supervise a work team to carry out construction, installation, modification, pre-commissioning tests, operation, maintenance and repair activities of facilities, plant, circuits, or other equipment in a safe, high quality and efficient manner
- Perform in-depth analysis to identify and resolve technical problems
- Assist Engineer/Senior Technical Officer in carrying out project management work (including liaison and coordination with internal and external stakeholders, project scheduling and resourcing, planned outages) in meeting customers' expectations and performance targets
- Provide training, supervise site work, and conduct audit check to ensure
 - i. work done by team members and contractors comply with approved working procedures, safety and quality standards, related specifications, proper risk mitigation measures, and legal requirements and
 - ii. good working condition of all tools and equipment and proper housekeeping are maintained
- Conduct timely inputting of data in company IT systems such as EWMS, EFMS, EPSS, IDMS, PSARS and other Document Workflow Control System (DWCS) as and when required
- Perform emergency call out work and work under adverse weather condition as and when required.

Requirements:

- Higher Certificate / Higher Diploma in Electronic, Electrical, Computer Engineering or Professional Diploma in Power Engineering or equivalent plus 2 years' relevant experience; **OR** Ordinary Certificate / Ordinary Diploma in Electronic, Electrical, Computer Engineering or Diploma in Power Engineering or equivalent plus 4 years' relevant experience

- Experienced in the installation, testing, fault investigation and development of electrical equipment and systems
- Authorized Person – Restricted Duties and Safety Supervisor qualification or equivalent would be preferable
- Construction Industry Safety Training Certificate
- A valid driving licence class 1 and 2. (For existing CLP staff, Company Authorized Driver is required)
- Good understanding of CLP Power Safety Rules and relevant statutory requirements, SHEQ requirements, codes of practice and relevant procedures
- Proficiency in the use of PC applications e.g. MS Outlook, Word, Excel
- Ability to work independently and to communicate technical concepts in English and Chinese (including Putonghua), both verbal and written
- Good supervisory skill and good problem solving & influencing skills
- Customer and result-oriented, self-motivated, good team player and able to work under pressure
