- Provide fault investigation, diagnosis, make recommendations and implement improvement and modification on the EV charging network and backend system
- Develop monitoring system and evaluate new technology and equipment for charging service improvement
- Administer, maintain and operate EV charging network and backend system in high availability
- Carry out tendering, contracting and subsequent contract management in maintaining EV charging network for delivering high quality services
- Establish policies, standards and conduct benchmarking and data analytics on EV and charging network
- Support EV related technology development for smart grid and smart city
- Ensure adequate and justifiable budgets are prepared and under control for project implementation, daily operation and maintenance activities
- Conduct training, seminars and develop education pack to educate the internal and external customers on EV issues
- Review safety plans, works and documentations prepared by subordinates and contractors to ensure its compliance with CLP Power Safety Management Systems
- Carry out emergency restoration and repairs after normal office hours when required
