Applications are invited for the above vacancy in Operations Branch of East & West Region. Reporting to the Engineer I, the appointee will be responsible for the following duties:-

- Plan and control projects activities, including materials and resources utilization
- Assist in formulating long and short-term outage plans and the associated work plans to meet the business objectives
- Liaise and co-ordinate with various departments of project works and plan, schedule, set up proper procedures and precautions to meet the Company's requirements and Safety Rules
- Ensure adequate and justifiable budgets being prepared for project installation and other activities, and control the related expenditure
- Review work and related documents including safety aspect, to ensure their compliance with company's policies and procedures and to provide recommendations for continuous improvement and cost effectiveness
- Carry out fault / defects investigation, and execute diagnosis, analysis and repairs works
- Evaluate and recommend suppliers and services contractors which can meet technical specifications and engineering standards to achieve construction and operational targets. Devise and implement systems to manage the performance of contractors
- Supervise work teams and services contractors in carrying out pre-commissioning checks/ commissioning tests on distribution equipment and in delivery of operational tasks including but not limited to trench work with cable laying, outage schedule and preparation, and distribution plant O&M works
- Perform emergency call out / repair work, shift work, and/or work under adverse weather condition as and when required

Requirements:

- A recognized university degree or equivalent in Electrical Engineering or relevant discipline
- At least three years' relevant engineering experience in electricity supply industry. Preference will be given to those with experience in Region operations

- Possess a valid driving license (class 1, 2) is preferred
- Familiar with CLP Power Safety Rules, relevant statutory requirements, HSSEQ requirements & code of practice and relevant procedures
- Be mindful and has good safety awareness and track record
- Analytical and able to work under pressure and tight schedule
- Strong sense of responsibility with good interpersonal and communication skills
- Ability to work independently and communicate technical concepts in English and Chinese, verbally and written
