- Design, construct and maintain metering systems to meet latest requirements of safety, integrity and reliability
- Lead work teams to conduct installations, replacement, testing, commission, operations and maintenance of metering systems
- Set, review and monitor service pledges and key performance indicators to meet HSSEQ, operational efficiency requirements and customer satisfaction
- Develop and implement control procedures and practices on project management, metering operations and contractor performance in accordance with the Company's management systems of health, safety, security, environment and quality (HSSEQ)
- Liaise with customers, developers, consultants, contractors, etc. to provide metering solutions to customers
- Handle enquiries and complaints related to customer supply and metering activities, share and transform lessons learnt into work practices for continuous improvement
- Compile budget plans and monitor expenditures
