The Deputy Company Secretary welcomed all Shareholders joining the Annual General Meeting in person or online, and mentioned that it was the first online live broadcast Annual General Meeting in Hong Kong. He thanked the CLP Holdings' Directors for their attendance at the Annual General Meeting and introduced the Directors present on stage.

The Chairman started the Meeting by welcoming all the Shareholders. He noted that CLP's Annual General Meeting had received tremendous support from our Shareholders and he thanked Shareholders for their continuing support and with the growing attendance, this year the Annual General Meeting was held at a larger venue. He also welcomed all Shareholders participating online via live webcast.

### Quorum and Notice

The Chairman noted that a quorum of Shareholders was present. The Notice convening the Meeting, which had been served to Shareholders, was taken as read with permission from all Shareholders present at the Meeting.

## Call for a Poll

The Chairman called for a poll on each of the resolutions submitted for determination at the Meeting and noted that the number of shares held by each Shareholder or proxy would be counted in the voting on the resolutions set out in the Notice.

In the interest of time and with permission from all Shareholders present at the Meeting, the voting by poll on each of the proposed and seconded resolutions would take place at the end of the Meeting.

The Chairman then addressed the Meeting as follows:

"Before we turn to the formal part of the meeting, I would like to take this opportunity to acknowledge the Group's good financial performance last year and to discuss our progress in growing and developing the business for a low carbon, digital future.

"Ladies and gentlemen, our financial results in 2018 were excellent, with dependable earnings in Hong Kong and a strong performance from our overseas businesses. Our operating earnings increased 5.1% to HK\$13.9 billion driven by a 30% increase in contribution from our businesses outside Hong Kong. This good result allowed us to increase our total dividend for 2018 to \$3.02 per share, an increase from \$2.91 in 2017.

"While our financial results in 2018 were pleasing, we should not lose sight of the fact that the power sector globally is undergoing rapid change driven by the need to transition to a low carbon future in combination with a dynamic period of innovation and technology development. As we have seen in Europe and North America, greater uncertainty and volatility can result from this change. In 2018 we made further strides to evolve our business to help meet these challenges. Starting with our governance practices, we have introduced some changes designed to ensure the gradual refresh of skills and experience on the Board over time so that we can continue to have the best Board for the Company in the years ahead.

"In our home market of Hong Kong, the new 15 year Scheme of Control Agreement took effect in October. While the new Agreement sees a lower level of return, which will result in lower earnings from the Hong Kong business in 2019, it gives us the clarity and certainty needed to move forward with our long-term investment plans in support of the Hong Kong Government's low carbon policy. The new gas-fired generation unit to be built at Black Point Power Station and our plan to develop an offshore LNG terminal are both very much part of this effort.

"We also made good progress on new initiatives to promote renewable energy development under the Scheme of Control Agreement through the Feed in Tariff and Renewable Energy Certificate schemes along with new programmes to promote energy efficiency and conservation.

"Outside of Hong Kong we are also progressing our effort to strengthen our businesses across the portfolio. In Mainland China, the regulatory reform process continues as the economy develops and the energy transition progresses. Our efforts over many years to build a low carbon business have positioned us well to manage these changes and the expected completion of the sixth and final unit at the Yangjiang nuclear plant in 2019 will further boost our presence in the country's low carbon future.

"In India, we took an important step in the development of our business with the introduction of the Canadian pension fund manager, Caisse de dépôt et placement du Québec, as a 40% shareholder of CLP India, which means they will now share 40% of the earnings from our Indian business. The transaction underscored the underlying value of the assets and reputation we have built in India, where we are one of the country's prominent renewable power producers. More fundamentally, the introduction of Caisse de dépôt et placement du Québec brings the long-term strategic backing and additional resources that will support CLP India's growth. We will continue to contribute to the expansion and improvement of the Indian power system through the continued growth of our renewable energy portfolio and in other parts of the energy supply chain that support the transition underway in India.

"Turning now to Australia, which is in the midst of a Federal election campaign where climate change and energy policy are two of the key issues. As I have said in the past, more coordinated planning and stable energy policies are needed to ensure that the transition to cleaner energy can be achieved without compromising reliability and affordability. We will continue to support Federal and state governments work toward a national approach to energy to address these challenges. In this environment, our business in Australia is faced with considerable uncertainty and market volatility. as our existing fleet of generating assets ages, reliability of performance becomes an increasingly complex challenge to manage and we must work harder and smarter to minimise production interruptions, particularly at times of high demand. In parallel, we will continue to focus our efforts on projects that will help stabilise and support the system as more intermittent sources of renewable energy come in. These include grid-scale batteries, pump storage, and gas plants that can be used at times of peak demand.

"The electricity supply industry is at the early stages of an exciting period of innovation and technological change. Improved technologies create new possibilities for us to deliver our products and services in a clean, reliable and affordable fashion, and to give our customers greater choice and control over the way they use electricity. The need to move more quickly toward a low-carbon future provides a further spur to action. We have seen an increased interplay between powerful digital technologies and more rapid adoption of renewable sources of energy. In recognition of these changes and the impact that they may have on our traditional utility businesses we have made innovation a priority area of focus. This, in combination with our efforts over many years to build a low carbon business, see the Group well positioned to make best use of these technological changes in building a sustainable business.

"Before concluding, I would like to make particular note of the fact that Dr Y. B. Lee will retire from the Board at the conclusion of this meeting. Y.B. has had a long and distinguished career with CLP both in management and on the Board and I would like to thank Y.B. for his excellent contribution over many years.

"Ladies and Gentlemen, while we are in an increasingly complex and rapidly changing environment, I am confident that the strength of the Group from the diversity of our business along with our long-term view and commitment to building a safe and sustainable business, will continue to hold us in good stead."

#### Directors' Report and Financial Statements

The 2018 Annual Report contained the Directors' Report and the Financial Statements for the year ended 31 December 2018 were taken as read with permission from all Shareholders present at the Meeting.

#### Independent Auditor's Report

The Independent Auditor's Report set out on pages 201 to 209 of the Company's Annual Report was taken as read with permission from all Shareholders present at the Meeting. Mr Sean Tuckfield, a partner of PricewaterhouseCoopers, summarised the Independent Auditor's Report as follows:

"PricewaterhouseCoopers' report on the consolidated financial statements of the Company and its subsidiaries for the year ended 31 December 2018 includes confirmation that we have conducted our audit in accordance with Hong Kong Standards on Auditing issued by the Hong Kong Institute of Certified Public Accountants, and that in our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2018, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants and have been properly prepared in compliance with the Hong Kong Companies Ordinance."

The Chairman thanked Mr Tuckfield and asked if there were any questions on the Independent Auditor's Report.

There being no questions on the Independent Auditor's Report, the Chairman continued:

"I now formally propose to receive the audited Financial Statements for the year ended the 31 December 2018 and the Reports of the Directors and Independent Auditor thereon. If anyone has any questions on the Reports and the Financial Statements, I would be pleased to answer them after my proposal has been seconded."

Ms Iu Kai Fan Fanny seconded the proposal to receive the audited Financial Statements for the year ended 31 December 2018 and the Reports of the Directors and Independent Auditor thereon.

The Chairman thanked Ms Iu and asked if there were any questions on the Directors' Report or the Financial Statements.

There being no questions on the Directors' Report or the Financial Statements, Ordinary Resolution (1) to receive the audited Financial Statements for the year ended 31 December 2018 and the Reports of the Directors and Independent Auditor thereon was put to Shareholders for voting by poll at the end of the Meeting.

## Election and re-election of Directors

In accordance with Article 125 of the Company's Articles of Association, Mr Philip Kadoorie and Ms May Siew Boi Tan, who were appointed by the Board during the year, retired from the office of Directors, and being eligible, offered themselves for election by Shareholders.

In accordance with Article 119 of the Company's Articles of Association, Mr John Leigh, Mr Richard Lancaster, Mrs Zia Mody and Mr Geert Peeters retired by rotation from the office of Director at this Meeting.

Under the Company's recently amended Board Diversity Policy and retirement age guideline, Non-executive Directors (other than the Chairman) would not be considered for re-election at an Annual General Meeting, if they would have reached the age of 72 at the time of the relevant Annual General Meeting. Dr Lee Yui Bor, who had been a Non-executive Director of the Company since 2007, had confirmed to the Company that, pursuant to the retirement age guideline, he would not be seeking re-election at this meeting and would therefore retire at the conclusion of this meeting.

All the other retiring Directors, being eligible, offered themselves for re-election at this Meeting.

Biographical details and interests, if any, in the shares of the Company of all the Directors who stood for election and re-election were set out in the Annual Report and in paragraphs 13, 15 and Schedule 1 to the Explanatory Notes to the Notice of Annual General Meeting.

Ordinary Resolutions (2)(a) and (2)(b) regarding the election of Mr Philip Kadoorie and Ms May Siew Boi Tan respectively as Directors of the Company were proposed by Mrs Chong Wong Wing Ting Elaine, seconded by Mr Tse Chi Hing Francis and put individually to Shareholders for voting by poll at the end of the Meeting.

The Chairman indicated that as Ordinary Resolution (2)(a) concerned the election of his son as Director, in his capacity as Chairman voting as proxy for other Shareholders, votes would only be casted in accordance with their specified voting instructions.

Ordinary Resolutions (2)(c), (2)(d), (2)(e) and (2)(f) regarding the re-election of Mr John Leigh, Mr Richard Lancaster, Mrs Zia Mody and Mr Geert Peeters respectively as Directors of the Company were proposed by Mr Ho Kwok Wing, seconded by Mr Lai Kam Tong and put individually to Shareholders for voting by poll at the end of the Meeting.

#### Reappointment of Auditor

The Chairman continued:

"The Financial Statements for the year ended 31 December 2018 have been audited by PricewaterhouseCoopers who, being eligible, offer themselves for reappointment, at a fee to be agreed with the Board."

Ordinary Resolution (3) regarding the re-appointment of PricewaterhouseCoopers as independent Auditor of the Company and the authorisation of Directors to fix the Auditor's remuneration for the year ending 31 December 2019 was proposed by Dr Chan Fuk Cheung, seconded by Ms Lam Kit Yee Carrie and put to Shareholders for voting by poll at the end of the Meeting.

# Remuneration payable to the Non-executive Directors

Resolution (4) was in relation to the revised levels of remuneration payable to Non-executive Directors including Independent Non-executive Directors who serve on the Board and Board Committees. As the Resolution concerned the remuneration of Non-executive Directors including the Chairman, the Chairman invited the Company Secretary, Mr David Simmonds, to briefly explain the background to the Resolution.

Mr David Simmonds noted that the current fees payable to the Non-executive Directors were approved by Shareholders in 2016 based on the results of an independent review undertaken in that same year. The CLP Code on Corporate Governance provided that CLP Non-executive Directors were to be paid fees in line with market practice based on a formal independent review undertaken no less frequently than every three years. Accordingly, at the beginning of 2019, a review of the level of fees payable to Non-executive Directors for the years 2019 to 2021 was undertaken.

The methodology adopted in the 2019 Review in all material respects was the same as that used in the previous reviews, taking into account the workload, scale and complexity of the business and the responsibility of Non-executive Directors. The proposed fees were then benchmarked against the level of fees paid to non-executive directors of other leading Hong Kong listed companies included within the Hang Seng Index and other Hong Kong indices, as well as fees paid to non-executive directors of utility companies listed on exchanges in Hong Kong, the UK, Australia and New Zealand.

The methodology applied in determining the proposed fees was unchanged from the 2016 Review, save for two adjustments. Mr David Simmonds explained the adjustments as follow:

"Firstly, the indicative fees show a slight reduction in fees for the Finance & General Committee. The reduction can be attributed to the delivery of more succinct board papers and enhanced efficiency in the Committee's work. Looking ahead, it is anticipated that the workload of the Finance & General Committee may increase over the next few years. In these circumstances, it is considered appropriate to maintain the current fees for the Finance & General Committee unchanged.

"Secondly, with the growing demand on the work of the Nomination Committee, it is proposed that the nominal fee now be discarded and the fees for the Nomination Committee should be determined by the application of our standard review methodology. This would result in a modest increase in absolute dollar value only."

The methodology and proposed fees had been independently reviewed by J.S. Gale & Co, external legal advisor, who had provided an opinion to the effect that the methodology adopted by CLP was reasonable and appropriate, had been fairly and consistently applied in all material respects and that the resulting proposed level of fees was reasonable and appropriate having regard to current corporate governance practices in Hong Kong and the UK.

Further details of the methodology and resulting fees were set out in the Human Resources & Remuneration Committee Report on pages 161 to 163 of CLP Holdings' 2018 Annual Report. The 2019 Review which contained J.S. Gale & Co's opinion was available on the CLP website.

Mr David Simmonds went on to note that in order to conform with the Company's policy that no individual or any of his or her close associates should determine his or her own remuneration, the proposed revised levels of fees had been considered and endorsed by the Human Resources & Remuneration Committee, and were put to Shareholders for approval at the Meeting.

The Chairman noted that as Ordinary Resolution (4) related to the remuneration of Non-executive Directors including himself, in his capacity as Chairman voting as proxy for other Shareholders, votes would only be casted in accordance with their specific voting instructions.

Accordingly, the following Ordinary Resolution (4) was proposed by Ms Ip Mun Yee Lisa, seconded by Mr Yee Kwok Choi Wilson and put to Shareholders for voting by poll at the end of the Meeting.

"Unless and until Shareholders otherwise determine in general meeting, the remuneration payable to the Non-executive Directors (including Independent Non-executive Directors) who serve on the Board and on the Board Committees of the Company shall be fixed at the levels as shown in the following table for the respective periods (i) 7 May 2019 to 6 May 2020; (ii) 7 May 2020 to 6 May 2021; and (iii) 7 May 2021 until the date of the Annual General Meeting in 2022, and that such remuneration shall accrue on a daily basis.

#### General Mandate to Issue Shares

The following Ordinary Resolution (5) was proposed by the Chairman, seconded by Ms Au Yuen Ling Winnie and put to Shareholders for voting by poll at the end of the Meeting:

#### "That:

(a) subject to paragraphs (c) and (d), a general mandate be and is hereby unconditionally granted to the Directors of the Company to exercise during the Relevant Period all the powers of the Company to allot, issue and dispose of additional shares in the Company; to make or grant offers, agreements, options or warrants which would or might require the exercise of such powers and to grant rights to subscribe for, or to convert any security into, shares in the Company;

- (b) the mandate in paragraph (a) shall authorise the Directors of the Company during the Relevant Period to make or grant offers, agreements, options and warrants which would or might require the exercise of such powers after the end of the Relevant Period;
- the shares allotted or agreed conditionally or unconditionally to be (c) allotted (whether pursuant to an option or otherwise) by the Directors of the Company pursuant to the mandate in paragraph (a), otherwise than pursuant to (i) a Rights Issue, or (ii) any option scheme or similar arrangement for the time being adopted for the grant or issue to the officers and/or employees of the Company and/or any of its subsidiaries of shares or rights to acquire shares of the Company, or (iii) any scrip dividend or similar arrangement pursuant to the Articles of Association of the Company from time to time, or (iv) an allotment of shares made in accordance with a grant of the right to subscribe for, or convert any security into shares provided that the right has been approved in advance by a resolution of the Company whether conditionally or unconditionally, shall not exceed five per cent (5%) of the total number of shares of the Company in issue at the date of this Resolution (as such number of shares may be adjusted in the event of any subdivision or consolidation of shares after the date of this Resolution) and the said mandate shall be limited accordingly;
- (d) any shares of the Company to be allotted and issued (whether wholly or partly for cash or otherwise) pursuant to the mandate in paragraph (a) of this Resolution shall not be at a discount of more than ten per cent (10%) to the Benchmarked Price of such shares of the Company; and
- (e) for the purpose of this Resolution:

"Benchmarked Price" means the price which is the higher of:

- the closing price of the shares of the Company as quoted on The Stock Exchange of Hong Kong Limited on the date of the agreement involving the relevant proposed issue of shares of the Company; or
- (ii) the average closing price as quoted on The Stock Exchange of Hong Kong Limited of the shares of the Company for the five trading days immediately preceding the earlier of:
  - (A) the date of announcement of the transaction or arrangement involving the relevant proposed issue of shares of the Company;
  - (B) the date of the agreement involving the relevant proposed issue of shares of the Company; or
  - (C) the date on which the price of the shares of the Company that are proposed to be issued is fixed.

"Relevant Period" means the period from the passing of this Resolution until whichever is the earlier of:

- (i) the conclusion of the next Annual General Meeting of the Company;
- (ii) the expiration of the period within which the next Annual General Meeting of the Company is required by law to be held; or
- (iii) the date on which the authority set out in this Resolution is revoked or varied by an ordinary resolution of the Shareholders in general meeting.

"Rights Issue" means an offer of shares open for a period fixed by the Directors of the Company to holders of shares of the Company or any class thereof on the register on a fixed record date in proportion to their then holdings of such shares or class thereof (subject to such exclusion or other arrangements as the Directors of the Company may deem necessary or expedient in relation to fractional entitlements or having regard to any restrictions or obligations under the laws of, or the requirements of any recognised regulatory body or any stock exchange in, any territory outside Hong Kong)."

#### Share Buyback Mandate

The Chairman noted:

"Resolution (6) relates to the Share Buy-back Mandate and your attention is drawn to the Explanatory Statement on Share Buy-back Mandate attached to the Notice of Annual General Meeting, which I believe has provided you with the relevant information, to enable you to consider and make an informed decision on the Share Buy-back Mandate. I now propose that Resolution (6) concerning the Share Buy-back Mandate be approved as an Ordinary Resolution of the Company."

There being no questions on the Share Buy-back Mandate, the following Ordinary Resolution (6) was proposed by the Chairman, seconded by Mr Kwok Man Chung Robert and put to Shareholders for voting by poll at the end of the Meeting:

#### "That:

(a) a general mandate be and is hereby unconditionally given to the Directors of the Company to exercise during the Relevant Period all the powers of the Company to purchase/buy back or otherwise acquire shares of the Company in issue in accordance with all applicable laws and the requirements of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited, provided that the aggregate number of shares so purchased/bought back or otherwise acquired shall not exceed ten per cent (10%) of the total number of shares of the Company in issue at the date of this Resolution (as such number of shares may be adjusted in the event of any subdivision or consolidation of shares after the date of this Resolution).

(b) for the purpose of this Resolution:

"Relevant Period" means the period from the passing of this Resolution until whichever is the earlier of:

- (i) the conclusion of the next Annual General Meeting of the Company;
- (ii) the expiration of the period within which the next Annual General Meeting of the Company is required by law to be held; or
- (iii) the date on which the authority set out in this Resolution is revoked or varied by an ordinary resolution of the Shareholders in general meeting."

#### Questions from Shareholders

Before poll voting, the Chairman invited questions from Shareholders.

Mr David Simmonds, the Company Secretary, relayed a question received from Mr Chan Kung Leung who asked about what CLP, as a well-established company, could do in the development of the Greater Bay Area.

Mr Richard Lancaster thanked Mr Chan for his question and responded that CLP had a very long history both in supplying energy to the Guangdong area and being part of the electricity infrastructure network that encompassed Hong Kong and cities in the Greater Bay Area. Around one third of CLP's power came from the Daya Bay Nuclear Power Station and through the pumped storage facilities in the Mainland, these provided ongoing support to the stability of the Hong Kong power system. With CLP's interconnection for more than 20 years, Hong Kong enjoyed a more reliable, stable and affordable power supply. CLP maintained very strong relationships with power companies throughout the Greater Bay Area, including both in Mainland China and in Macau. He noted that there would be benefits from further integrating, and strengthening the reliability and performance of, the power industry in the Greater Bay Area and that these would be good opportunities for both CLP and Hong Kong.

The Chairman added that his late father had envisaged providing electricity to the then Canton back in the days of World War II and but for the war, power from Hong Kong through the 11kv overhead cable would have been provided at that time. He emphasised that it had always been CLP's view that CLP should be in a position to contribute to the development of the Greater Bay Area.

A Shareholder commended the encouraging financial results of CLP Holdings in 2018, particularly for Australia, which achieved steady earnings growth since 2014. He then asked about the fluctuations of CLP India's earnings as he observed that since 2015, earnings from India were no longer stable and that in 2018 there was a decline of 11%.

The Chairman thanked the Shareholder for his questions and explained the importance of diversification to CLP. For CLP's investments in different markets, some markets would perform better than others from time to time; it had always been in the Company's best interest to take a long-term view on our

#### investments.

Mr Lancaster highlighted that in 2018, there was a fundamental change in our business in India as CLP had brought in a very strong financial investor as its partner – CDPQ, which was well aligned with CLP in growing the India business. This also meant that there was a reduction of 40% of the CLP India earnings contribution and in addition, the Paguthan plant's power purchase agreement had expired. CLP's view of the India market was that it presented good opportunities for the power sector given that a large percentage of the population in India did not have access to electricity and that India was planning for decarbonising its energy sector; continuous investment in renewable energy and in transmission system remained much needed.

Mr Lancaster explained that in light of the opportunities in the market CLP would focus more on acquisitions of assets and businesses in India, in addition to developing greenfield projects. CLP's focus would be to participate in the transition to clean energy, which meant continuing with our development in the renewable energy portfolio across India and to look for new opportunities in the transmission sector.

Ms Ng Mei Yung noted that HK Electric Investments Limited, which had provided stable dividend payouts in the past, was planning to reduce its dividends by about 20% in the coming years so she asked if CLP had a similar dividend reduction plan. She also asked if CLP was worried about the passing of the Extradition Bill in Hong Kong given that CLP had businesses in Mainland China.

The Chairman noted that he had no concerns with the proposed Extradition Bill in Hong Kong. With regard to earnings, he said that the reduced permitted return under the new Scheme of Control Agreement would impact on the earnings of the Company. However, the Company would look at ways to grow and increase its earnings; and, in turn, maintain the dividends. He further added that as a shareholder, he was equally interested in the Company's dividends as other Shareholders.

Mr Richard Lancaster commented that as a law-abiding company CLP had no concerns over the proposed Extradition Bill. As regards dividends, management aims for steady and sustainable growth for dividend payouts. He added that the reduction in the permitted return in Hong Kong under the new Scheme of Control Agreement had already been factored into CLP's planning. Despite this reduction, management would expect to maintain stable dividends, and hopefully for dividends to continue to grow. He explained that CLP should be able to maintain its growth having regard to the HK\$52.9 billion Development Plan for CLP's investment in Hong Kong over the next 5 years, and the opportunities to grow CLP's business in India and in other places within CLP's business portfolio over the next few years.

Responding to a written question from a Mr Lee regarding the decreasing earnings per share of the Company since 2017, Mr Lancaster explained that the total earnings of the Company decreased in 2018 due to an impairment item related to the India business, but the total operating earnings and the total

operating earnings per share had increased. Mr Lancaster further supplemented that the impairment item related to India was a non-cash item reflected in the earnings but not in the cashflow.

Ms Brenda Poon enquired about the progress of the Argyle Street redevelopment project. Mr Richard Lancaster replied that as reported in the previous annual reports, CLP had partnered with the Sino Group for the redevelopment project, after having gone through an extensive regulatory approval process. He added that it would take about 3 years for the project to complete and the work had been progressing well.

Mr Cheung Kam Cheong asked whether the Company would consider investing in Australia, or markets which had weaker currencies, with the extra capital received from the divestment of the 40% interest in CLP India.

Mr Richard Lancaster noted that it was CLP's intention to reinvest the proceeds received from the divestment into India in order to grow the business there. He added that in order to minimise foreign currency risk proceeds in Indian rupees could be used for investment in India; and our Australia business was relatively low-geared so we have the capacity to raise debts in Australian dollars to fund further investment in Australia.

Mr Yu Henry Luk Heung said that as far as he knew Taiwan would reduce nuclear energy production in the coming one to two years. However, China would increase its nuclear power production. He would like to know the Chairman's views on whether the Company supported the increase or decrease in nuclear power generation.

Mr Richard Lancaster explained that there were uncertainties and different approaches in the policies towards nuclear energy in Taiwan. In China, there was clear policy support for nuclear power and that many new nuclear power stations were being built. There was also tremendous investment in the technology, and the capabilities not just amongst state-owned enterprises but also at the regulatory level as well. In Hong Kong, a public consultation would be launched soon where we would have a say on how Hong Kong energy policy would evolve to meet the 2050 climate change targets. Nuclear power had been a cornerstone for Hong Kong's zero carbon emission for more than 25 years and it would be an important decision for Hong Kong people to consider whether nuclear power would play a greater role in the energy mix in the future. This would be a decision to be taken by the Hong Kong Government in consultation with the community in Hong Kong. Whilst we would not expect a nuclear power station could be built in Hong Kong, there were opportunities for CLP to access nuclear power from Mainland China, just as we had done with Daya Bay over the past 25 years.

Mr Yu thanked the Chairman and Mr Richard Lancaster for their replies but he would like to ask for the Chairman's personal views on nuclear power. The Chairman explained that he was of the view that nuclear power would keep a lower carbon footprint (zero carbon emission) for Hong Kong and he added that the nuclear power from Daya Bay had been good for Hong Kong and it would be

good for Hong Kong in the future. However, such decision must be made between the Hong Kong Government and the general public.

Mr David Simmonds, the Company Secretary, added that there were two procedural questions received from the Shareholders who participated online and these would be addressed in the poll voting session. Mr Michael Ling, the Deputy Company Secretary, confirmed that registered shareholders who participated in the online AGM had the right to vote through the online system.

Poll

As all the resolutions have been proposed and seconded, the Chairman continued:

"I now direct that a poll on each of the resolutions be taken. The poll will be administered and scrutinised by the Company's Registrar."

The Deputy Company Secretary, Mr Michael Ling, explained to Shareholders the voting procedure by poll using the electronic voting system with a step-by-step demonstration and a test resolution.

Shareholders present at the Meeting or participated online through live webcast were given sufficient time to cast their votes using the electronic voting system. After Shareholders had completed their voting, the Chairman then declared the poll closed.

The Chairman then announced that all resolutions had been carried. He added that the results of the poll would be published on the Company's and Stock Exchange's websites; as well as in the Minutes of the Annual General Meeting which would be published on the Company's website in due course.

Conclusion

There being no further business, the Meeting concluded at 12:35 p.m.
