### 1. 2023 Annual Report, 2023 Sustainability Report and updated Climate Vision 2050

The Annual Report includes our sustainability-related disclosures made in accordance with the Environmental, Social and Governance Reporting Guide of the Stock Exchange. Our Sustainability Report and updated Climate Vision 2050 are also available on our website.

### 2. Arrangement for means of receipt of Corporate Communications<sup>1</sup> – CLP is adopting the new regulatory Paperless Listing Regime; kindly observe the arrangements below regarding how you may request for Printed Form and your provision of email address

There are two ways in which we disseminate our Corporate Communications, namely, (a) in Electronic Form, i.e. electronic means through the websites of CLP and the Stock Exchange, or (b) in Printed Form.

**If you wish to choose to receive Corporate Communications** (in English and/or Chinese) (a) in Electronic Form, or (b) in Printed Form; please refer to the enclosed Request Form and take one of the following actions:

- (a) scan the QR Code on the Request Form and send the automatically generated email to provide your email address for the Electronic Form; or
- (b) complete and sign the Request Form and return it to the Company's Registrars using the prepaid mailing label or by email to [clp.ecom@computershare.com.hk](mailto:clp.ecom@computershare.com.hk).

**If you choose the Electronic Form, you can provide an email address;** if the email address is not functional, you will be unable to receive email notifications regarding the publication of Corporate Communications on CLP website, in which case, you may have to check the websites of CLP and the Stock Exchange for our Corporate Communications. If the email address is not functional or you do not provide an email address at all, we will notify you by post to your registered address whenever a Corporate Communication has been made available on CLP website.

**If you would like to receive the Printed Form,** you will have to complete the Request Form as per the above instructions and observe the deadline below. Once you have made a valid request for the Printed Form, this will continue to be valid until the instructions have been revoked or superseded.

**Deadline of 25 April 2024 (deemed selection of Electronic Form)** – If we do not receive your duly completed and signed Request Form opting for the Printed Form by the deadline, you will be deemed to have selected to accept the Electronic Form. You will be notified by email whenever a Corporate Communication has been made available on CLP website and if no email address is provided, by post to your registered address.

Regardless of the above arrangements, you may at any time, (a) change your choice<sup>2</sup> of language (English and/or Chinese) and/or means of receipt of our Corporate Communications, or (b) if you encounter difficulties in accessing the Corporate Communications electronically, you can request for the Printed Form. You can do so by completing and returning the Request Form (available on CLP website under "Shareholder Services" in the "Investor Relations" section) by posting it to 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong or by email to [clp.ecom@computershare.com.hk](mailto:clp.ecom@computershare.com.hk). The instructions or changes covered herein can be made free of charge.

Actionable Corporate Communications<sup>3</sup> – The above arrangements on Corporate Communications do not relate to Actionable Corporate Communications (which seek shareholders' instructions on relevant corporate actions). Actionable Corporate Communications in Printed Form will be sent to shareholders individually by post to the registered address regardless of your choice of means of receipt of Corporate Communications.
