1. 2024 Interim Report

2. Arrangement for means of receipt of Corporate Communications

For those who have chosen to receive our Corporate Communications in Electronic Form, you will continue to be notified of the publication of Corporate Communications on CLP website in the selected manner (until you submit a change request³).

Notifications for Electronic Form – we recommend that you liaise with your Intermediary(ies)⁴ and provide them with your email address for notification purposes, if none is provided, you will be notified by post.

Regardless of the above arrangements, you may at any time, (a) change your choice³ of language (English and/or Chinese) and/or means of receipt of our Corporate Communications, or (b) if you encounter difficulties in accessing the Corporate Communications electronically, you can request for the Printed Form. You can do so by completing and returning the Request Form (available on CLP website under "Shareholder Services" in the "Investor Relations" section) by posting it to 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong or by email to clp.ecom@computershare.com.hk. The instructions or changes covered herein can be made free of charge.

3. Second interim dividend

On 5 August 2024, the Board declared the second interim dividend for 2024 of HK\$0.63 per share payable on 13 September 2024 to Shareholders registered as at 4 September 2024. The Register of Shareholders will be closed on 4 September 2024.
