### 1. 2025 Interim Report

### 2. Arrangement for means of receipt of Corporate Communications

If you do not take any action, we will disseminate our Corporate Communications to you in Electronic Form with a notification by email or by post (if no email address is provided).

You may at any time (free of charge), (a) change<sup>4</sup> your choice of language and/or means of receipt of our Corporate Communications, or (b) if you encounter difficulties in accessing the Corporate Communications electronically, you can request for the Printed Form.
