CLP Statement on Fraudulent Website

CLP Holdings Limited (CLP or the Company) has noticed recently a fraudulent website making unauthorised use of CLP's name, trademark and other CLP's photos and information. It is misleading the public that it is offering investment opportunities in various energy projects in relation to CLP's businesses. The fraudulent website also attempts to collect personal information by requesting members of the public to create accounts with it. Accordingly, CLP would like to alert its customers and the general public to the following fraudulent website, which purported to be a CLP website:

https://www[.]clpgroup[.]icu

CLP has no connection with the above fraudulent website, contents of which were neither authorised nor endorsed by the Company. CLP takes the matter very seriously and would like to reiterate that the Company's official website is www.clpgroup.com, and the official website of its subsidiary CLP Power Hong Kong Limited is www.clp.com.hk. CLP also suggests the public to verify the website name displayed in the browser first, and not visit or respond to the fraudulent website or any other suspicious website, email or messages, and not to provide any personal information casually. This case has been reported to the Hong Kong Police Force and the Hong Kong Computer Emergency Response Team Coordination Centre. In the meantime, CLP reserves all legal rights against the parties involved in this matter.

With the growing frequency of scam websites and phishing messages, the public should exercise increased caution and if there are any concerns, please contact CLP at clp_info@clp.com.hk or report to the police.
