# CLPe Launches EV Charging Service for Taxi and Commercial Fleets to Support the Expansion of Green Motoring in Hong Kong

According to the Hong Kong SAR Government's *Green Transformation Roadmap for Public Buses and Taxis*, around 3,000 electric taxis are expected to be on the roads of Hong Kong by 2027. To meet the charging needs of commercial electric vehicles (EVs), CLPe has launched an EV charging service focusing on fast and super-fast charging, and offers a variety of charging solutions for commercial vehicles, including taxi fleets, light goods vehicle fleets, and limousine fleets. CLPe has also partnered with Link Asset Management Limited (Link) to expand the charging network in Hong Kong Island, Kowloon, and the New Territories. More than 250 charging bays will be in service across Hong Kong, with the majority of them in Link's car parks in 2025.

CLPe has launched a mobile app called CLPe Charging, with optimised features and an online fleet management platform to provide business customers with a seamless, one-stop charging experience. The app allows customers to search for the nearest CLPe charging station based on their location, monitor charging status in real time, check charging records, and pay charging fees. The online fleet management platform allows customers to view their fleet's charging data and energy costs, manage fleet accounts, monitor fleet charging demand and business management.

CLPe is meanwhile in discussions with the city's five licensed taxi fleets – Big Boss Taxi Company Limited, CMG Fleet Management Limited, Sino Development (International) Company Limited, SynCab Service Limited, and Tai Wo Management Limited – to provide charging services tailored to their operational needs, supporting the development of electric taxi fleets.

CLPe Managing Director Mr Ringo Ng said, "We are delighted to provide a one-stop EV charging service for taxi and commercial fleets, and to partner with Link to expand the network to meet growing demand for commercial EV charging. In addition, we are exploring the expansion of the charging network in other areas and will continue to optimise the charging solutions to fully support the needs of commercial EVs."

Big Boss Taxi Company Limited Chief Operating Officer Mr Alex Chiu said, "We prioritise effective fleet management and high-quality service. CLPe's charging stations are conveniently located near facilities for our drivers to eat and rest, which meets the operational and development needs of our taxi fleet."

SynCab Service Limited Executive Director Ms Sonia Cheng explained that her company's fleet has significant charging demand. "Our fleet is over 90% electric which makes the management of charging costs a vital component of our business. Accessing this information in real time through the online platform significantly enhances our ability to allocate resources effectively."

Limousine service provider King's Limousine Company Limited Managing Partner Mr Donald Cheng said, "Business clients place greater importance on sustainability today and we have introduced more EVs into our fleet. Accessing fast charging services in the city centre perfectly complements the areas and routes we frequently service."

CLPe has commissioned over 100 charging bays in Wong Tai Sin, Kwun Tong, Tseung Kwan O, Tsing Yi, and Sha Tin<sup>1</sup>, most of which are located in Link's car parks, to provide fast and super-fast charging services to meet the operational needs of commercial EVs. Competitively priced medium-speed charging facilities are also available for commercial EVs parked overnight. CLPe plans to increase the number of charging bays to more than 250 in Link's car parks in Chai Wan, Sham Shui Po, Yuen Long and Tung Chung and other car parks by 2025 to cover more districts.

Link HK Property & Car Park Management Managing Director Mr William Lai said, "Link has been instrumental in powering Hong Kong's transition to a greener and smarter city. Moving forward, Link will continue to work closely with stakeholders to enhance the charging experience for different types of EV owners and further promote the adoption and growth of EVs in Hong Kong."
