CLP Power Teams up with Restaurants and Businesses on Earth Day to Reduce Carbon Emissions by 50 Tonnes with Renewable Energy Certificates

Today (April 22) is Earth Day, CLP Power Hong Kong Limited (CLP Power) has acted on this year's theme of "Our Power, Our Planet" to call on businesses across the city to promote renewable energy development in Hong Kong. A total of 23 customers in catering industry and other business sectors will offset carbon emissions from the electricity consumption of their operations today through the purchase of CLP Renewable Energy Certificates (RECs). The businesses have bought nearly 130,000 kilowatt hours (kWh) of CLP RECs, equivalent to a reduction of around 50 tonnes¹ of carbon emissions (See attachment for full list of participating businesses).

LH Group Chairman and CEO Professor Simon Wong fully supports the campaign and said, "LH Group is committed to sustainable development. We have purchased CLP RECs for five consecutive years to help reduce our operational carbon emissions. Today is World Earth Day. We hope that everyone will work together to save energy and reduce carbon emissions, supporting Hong Kong in achieving its carbon neutrality goal by 2050."

NAGE Taiwanese Cuisine also participated in the campaign. Representative Mr Wong Ka Kin explained, "We are committed to improving the energy efficiency of our operations. Our new branch in Kwun Tong has adopted an all-electric kitchen, which not only provides a more comfortable working environment for our staff but also helps save energy costs. Today, by purchasing CLP RECs, we have offset carbon emissions from the electricity consumption of our seven restaurants in Kowloon and the New Territories. We hope this action will set an example and encourage more of our friends in the catering industry to embrace low-carbon dining."

CLP Power Senior Director of Customer Success and Experience Ms Lena Low said, "CLP RECs help business customers accelerate their carbon reduction goals. We are delighted to join hands with various customers to support Earth Day and promote low-carbon transformation in different industries. CLP RECs have been well received by

customers. By the end of 2024, over 630 gigawatt-hours (GWh) of CLP RECs were sold, equivalent to a reduction of about 245,000 tonnes² of carbon emissions.”

CLP Power accords top priority to decarbonisation in its business operations through energy transition and low-carbon generation. This includes phasing out coal-fired generation, promoting the development of local renewable energy, enhancing regional cooperation to source more zero-carbon energy, and promoting electrification to achieve decarbonisation in a holistic manner. The company will also continue to support different sectors to save energy and decarbonise to help Hong Kong achieve carbon neutrality by 2050.

The price for an CLP REC is HK\$0.5 per unit, with a minimum purchase of 100 units. CLP Power’s residential and commercial and industrial customers can purchase RECs to claim the environmental attributes of electricity produced by local renewable energy sources and offset carbon emissions from their electricity consumption, while supporting the development of renewable energy in Hong Kong.
