CLPe Fully Supports Government's Fast Charger Incentive Scheme Provides More Fast Charging Facilities to Support Growing Demand

The Hong Kong SAR Government announced the details of the Fast Charger Incentive Scheme today (25 July). CLPe fully supports the Government's initiative to expand fast charging services and will provide more fast and ultra-fast charging facilities to address the growing charging demand from the private and commercial electric vehicle (EV) sectors, thereby promoting green transport.

CLPe is currently in close discussions with commercial fleet operators, property developers, property management companies and large shopping mall owners to expand charging services focusing on fast and ultra-fast charging on Hong Kong Island, and in Kowloon and the New Territories. More than 250 chargers will be in service in 2025, and CLPe targets to increase the total to nearly 1,000 chargers in the coming two years.

CLPe Managing Director Mr Ringo Ng said: "Hong Kong's EV market is experiencing rapid growth, with over 110,000 EVs on the road. CLPe welcomes the Government's Fast Charger Incentive Scheme and we will strive to accelerate the provision of fast-charging facilities to support demand from private and commercial EVs. We hope this will benefit taxi fleets and the electric heavy-duty truck industry while supporting Hong Kong to achieve the goal of zero vehicular emissions before 2050."

CLPe fully supports the development of electric taxi fleets, and will provide charging services for a number of taxi fleets. It is actively engaging other licensed taxi fleet operators to deliver customised charging solutions that meet their operational requirements. CLPe is also planning to introduce Hong Kong's first five-axis electric heavy crane lorry and provide one-stop battery leasing, charging, swapping and maintenance service for electric heavy trucks, to promote electrification in the heavy truck sector.

To complement its charging services, CLPe offers a mobile app called CLPe Charging, a range of charging solutions and an online fleet management platform, enhancing the user experience for both private and fleet customers.
