CLP Power Supports Initiatives to Accelerate Northern Metropolis Development, Enhance Electric Vehicle Charging Network and Promote Low-altitude Economy Ecosystem in the Policy Address

CLP Power Hong Kong Limited (CLP Power) welcomes and supports the initiatives announced by the Chief Executive the Honourable John KC Lee in the 2025 Policy Address today (17 September) including the establishment of the Committee on Development of the Northern Metropolis to expedite Northern Metropolis development, enhancement of the electric vehicle (EV) charging network, and further promotion of the low-altitude economy (LAE) ecosystem.

CLP Power Managing Director Mr Joseph Law said, "CLP Power fully supports and actively participates in the development of the Northern Metropolis. We are committed to meeting the electricity needs of the area on all fronts and will expedite the enhancement of power supply works in line with the pace of the development."

He added, "As an orchestrator of the local EV ecosystem, CLP Power is dedicated to promoting the wider adoption of EVs in Hong Kong, in alignment with the Government's goal of achieving zero vehicular emissions and carbon neutrality before 2050. We have introduced a range of initiatives to encourage the installation of EV fast charging facilities, supporting the Government and industry to accelerate the expansion of the local EV charging network. These include proactive identification of around 8,000 potential locations for fast charger installation, enabling more effective planning and deployment of fast chargers to enhance the scale and coverage of EV charging."

Regarding the Government's plan to enhance the LAE Regulatory Sandbox Pilot Projects, Mr Law said, "CLP Power adopted Beyond Visual Line of Sight (BVLOS) operations to inspect transmission towers and overhead lines as one of the first batch of participants in the LAE Regulatory Sandbox Pilot Projects which has boosted inspection efficiency of transmission towers and overhead lines significantly. We will continue to closely monitor the development of the Sandbox Pilot Projects and the

'Regulatory Sandbox X' to explore different BVLOS application scenarios to further enhance power supply reliability."

CLP Power will continue to leverage its power expertise to support the Government in fostering a green and low-carbon living environment, and achieving carbon neutrality before 2050.
