

HKEx ESG Reporting Guide – Content Index

With the new Stock Exchange Environmental, Social and Governance Reporting Rules and Guides (the Reporting Guide) that have yet to become effective for CLP's 2019 Annual Report, the Company has adopted these, in particular, the “comply or explain” provisions set out in Part C of the Reporting Guide. In line with the Stock Exchange Reporting Principles for this new ESG reporting framework, materiality is regarded as fundamental to CLP's ESG reporting. The materiality assessment process enabled management to determine those material ESG topics to CLP.
