- A Shareholder entitled to attend and vote at the AGM is entitled to appoint a proxy to exercise the Shareholder's rights at the AGM. Subject to the statutes, any such proxy may attend, speak and vote in his/her stead. The proxy need not be a Shareholder of the Company but must attend the AGM in person to represent you.

- The full wording of the resolutions to be proposed at the AGM and Explanatory Notes are set out in the Notice of AGM which is available on our website and sent to all Shareholders on 28 March 2018.
- In order to be valid, **proxy forms must be completed, signed and either deposited at the Company's Registrars, Computershare Hong Kong Investor Services Limited, 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong or via email to CLP2018.eproxy@computershare.com.hk**, in each case, not less than 48 hours (excluding any part of a day that is a public holiday) before the time for holding the AGM.
- The email address provided in paragraph 6 is provided only for receiving proxy forms relating to this AGM. The email address shall not be used for any other purposes nor shall it be in use after the deadline stated in paragraph 6 above.
- The Chairman will demand a poll on each of the resolutions submitted for determination at the AGM. On a poll, every Shareholder present in person or by proxy or (being a corporation) is represented by proxy shall have one vote for every share held by him/her. The results of the poll will be published as explained in Explanatory Note 26 of the Notice of AGM.
- Your proxy's authority will be revoked if you attend and vote in person in the AGM.
- The Company has prepared a limited number of AGM souvenirs as gifts. **Every Shareholder attending the AGM in person or by proxy will be offered one set of souvenir only regardless of the number of shares he/she holds or represents, or the number of Shareholders he/she represents.** Allocation of additional souvenirs to multiple appointed proxies will be at the Company's discretion and subject to the availability of souvenirs.

PERSONAL INFORMATION COLLECTION STATEMENT

"Personal Data" in this statement has the same meaning as "personal data" in the Personal Data (Privacy) Ordinance, Cap 486 (PDPO), which will include your and your appointed proxy's name and mailing address.

The Personal Data provided in this form may be used in connection with processing your appointment of proxy at the Company's AGM and instructions. Your supply of the Personal Data to the Company and/or its Registrars is on a voluntary basis. However, we may not be able to effect the appointment of your proxy and instructions unless you provide us with the Personal Data. The Personal Data will not be transferred to any party outside CLP or its Registrars, unless it is required to do so by law, for example, in response to a court order or a law enforcement agency's request.

The Personal Data collected in this proxy form will be retained for such period as may be necessary for any of the above purposes and its directly related purposes such as for our record, verification and notification purposes, and this proxy form together with the Personal Data contained in this form will be destroyed no later than 1 year after the AGM.

You and your appointed proxy have the right to request access to and/or correction of the respective Personal Data in accordance with the provisions of the PDPO. Any such request for access to and/or correction of the Personal Data should be made in writing by either one of the following means:
